The Department recognizes the intent of the proposed legislations seeking to enhance and strengthen the existing governance structure of the Energy Regulatory Commission, amending for that purpose, Republic Act No. 9136, otherwise known as the Electric Power Industry Reform Act (EPIRA) of 2001.

The DTI agrees that the Energy Regulatory Commission (ERC), as the regulator of distribution and transmission of electricity, has a definitive role in safeguarding the interest of the public. The ERC is mandated to: ensure transparency and reasonable prices of electricity; and promote competition and ensure market development in the Electric Power Industry. It is under this purview that the Department agrees that there is a need to revisit the governance structure of the ERC to address possible sources of imbalance in power and accountability.

As may be noted, under the current set-up, the Chairman of the Commission is responsible for steering the strategy, policy, deliberations and discussions of the members of the Commission, as well as, managing the day-to-day operations of the ERC. To foster an appropriate balance of power, increased accountability, and better capacity for independent decision-making, we concur with the proposal to create a separate Executive Director position who would assume the Chief Executive Officer tasks such as overseeing and managing the day-to-day operations of the Commission, thereby relieving the Chairperson of this task for him/her to exert all efforts instead to policy-making, strategic planning and presiding over Commission meetings.

The Department also commends the initiative to prohibit members of the Commission and their relatives, within the fourth civil degree of consanguinity or affinity, to be an investor, stockholder, officer or director, in any company or entity engaged in the business of generating, transmitting, distributing or supplying electricity. Complementary to this, the DTI also agrees that a code of ethics for the Commission be formulated to ensure efficient and effective public service delivery.

However, the Department deems it more appropriate that the People's Desk be under the administrative supervision of the Commission or Department that handles the specific concern. Consistent with the pertinent policies governing consumer complaints, electricity-related concerns are currently being relayed to

either the Department of Energy (DOE) or the Energy Regulatory Commission (ERC). (Please see Annex A) When taken together, all these initiatives are expected to contribute to transparency and accountability which would ultimately redound to quality service for the Filipino people.

In view of the foregoing, the Department would like to provide the following comments, suggestions and recommendations, to wit:

- Supports the initiative of a strengthened consumer protection mechanism through the promotion of competition in the power and energy sector and provide better protection to its consumers as proposed by both proposed legislations; and
- Defers to the wisdom of the Department of Budget and Management (DBM) and the Department of Finance (DOF), on the proposal of both bills to exempt ERC from the Salary Standardization Act and be granted fiscal autonomy.

To reiterate, the DTI sees the need to revisit the governance structure of the ERC to further promote transparency, accountability and efficient delivery of public service in the energy and power sector, subject to our comments and recommendations.
